DIRECTIONS FOR USE: Fill the spray tank half full with clean water and start agitation. Add the acetic acid based herbicide according to label rate to the spray tank. Continue agitation and then add Contact Organics Boost at the recommended rate. Then add the remaining water. Mix thoroughly and maintain agitation during the application of the spray material. Apply spray material promptly.
